COURSE DESCRIPTION

This course explores women's involvement in three primary areas of criminal justice - as victims, criminals, and practitioners employed in criminal justice agencies. Topics covered include the impact of sex and gender on criminological theory, sentencing, prison subcultures, victimization, and career choices. This course has multicultural content and is writing intensive. **Prerequisite: CJ 1310 with a grade of "D" or better.**

LEARNING OBJECTIVES

Students who complete this course will have the necessary knowledge and skills to examine and comment on the challenges faced by women in the criminal justice field, more specifically, as they relate to their involvement as victims and offenders.

This goal is achieved through various activities, including attending class, taking notes, participating in class discussions, reading assigned material, and asking questions during class and/or office hours.

ATTENDANCE AND PARTICIPATION

<u>Participation:</u> Regular attendance is essential and expected. You must do the readings and actively contribute to the learning environment by showing that you are actively engaged in learning the material. You must come to class prepared to interact and be up-to-date on the assigned readings and activities.

<u>Technology/Electronic Devices:</u> Students are allowed to use laptops and tablets for taking notes in this course. Students are not allowed to use their cell phones for note-taking purposes, which includes taking pictures without permission. Students caught using cell phones during class will be asked to leave and will receive a zero for any classroom activities that day. **Recording lectures is not permitted**. Please also see the policy "<u>Recordings</u>" in this syllabus.

<u>Absences:</u> Students without university-recognized absences will not be allowed to make up missed assignments or exams and will receive a grade of 0. An excused absence will be granted in the case of a documented, physician-ordered illness, death in the immediate family, or other documented crisis, a call to active military duty or jury duty, a religious holy day, or an official university activity. If you miss an assignment or exam due to an emergency, please 1) notify me as soon as possible or 2) contact the Dean of Students Office to make an absence notification request at: <u>https://www.dos.txst.edu/services/care-center/absence.html</u>. <u>Appointments and E-mail:</u> Students are encouraged to meet with me at their convenience to address questions, concerns, and any other issues that may arise regarding the course. Outside of office hours, I am available by appointment on campus and via Zoom.

EVALUATION

<u>Attendance (10%)</u>: Students are expected to attend class. As such, points will be earned for each class session you attend. Attendance will be taken using a QR code available on Canvas. (<u>Total:</u> 100 points)

<u>Reflections (20%)</u>: I will assign three out-of-class documentaries throughout the semester. We will dedicate a small part of the following class to discussing each documentary. Further, you will submit a short reflection (one to two paragraphs) on Canvas. Each reflection will be worth 10 points (<u>Total:</u> 30 points)

<u>Packback (30%)</u>: Participation is a requirement for this course, and the Packback Questions platform will be used for online discussion about class topics. Packback Questions is an online community where you can be fearlessly curious and ask open-ended questions to build on what we cover in class and relate topics to real-world applications. Your participation in Packback will count toward 30% of your overall course grade. Each Packback is worth 10 points. Late assignments will not be accepted. (Total: 90 points)

<u>In-class activities (20 %):</u> Multiple in-class activities will occur throughout the semester. Some will require uploading files to the Canvas page, while others will be participation-based. For this grade, you must actively participate in the activities. If you miss class, you won't be able to make up for these points. If you have a university-accepted excuse, you will be asked to write a page of text about your intake on the activity (Total: 100 points)

Exams (20%): There will be two non-cumulative exams during the semester. Exams will be held in person and are worth 100 points each (multiple-choice questions). Students will be tested on information from lectures and assigned readings. Make-up exams will only be granted for students who have approved, university-recognized absences and will be in essay format. (Total: 200 points)

OR

<u>Final Project (20%):</u> You can work on a final project instead of taking the two exams. The goal of this project is to utilize the information provided throughout the course by applying aspects from class to the creation of a project focusing on one (or more) class topics. This project aims to identify how well you understood the information provided in this course and apply that knowledge. Points will be deducted if extensive reiteration of my PowerPoint occurs.

• You must select a topic covered in class (i.e., women as perpetrators, prostitution, women's victimization experiences) and thoroughly explain it.

• This project has two parts: 1) create a visual/audio summary of your topic 2) write a paper to describe in detail the topic and your project.

<u>Important:</u> Email me if you have another idea for a final paper. I am open to receiving your work in a different format than a paper, but I must approve it first. Failure to email me before the conception of your project may result in a grade drop. (Total: 200 points)

<u>Extra Credit</u>: Students will have opportunities throughout the semester to earn bonus points (up to 5). Bonus assignments will be posted a week before their due date.

<u>Grades</u>: All grades will be posted in the gradebook on the Canvas course website.

Final grades will be out of 390 points:

90%-100% = A 80%-89%= B 70%-79%= C 60%-69% = D ≤ 59% = F

Any grade disputes for assignments, exams, and/or the final grade must be submitted in writing within one week after the grade is given with clear and substantial reasons for the desired grade change. I will not discuss grades without first receiving this written statement. However, if you believe an error has been made with your grade, please bring that to my attention as soon as possible.

LATE POLICY

You will be responsible for submitting your work (**Word format**) on Canvas **before midnight on the day of the deadline**. For instance, your first reflection will be due on January 30th. This means that you will have all day and evening of January to finish working on it. I highly recommend you start your work early as it will give you plenty of time. To remain fair to everybody in the class, **late work will not be accepted unless for a university-approved reason,** in which case I urge you to contact me as soon as you can.

<u>Gun policy:</u> Effective August 1, 2016, concealed carry of a handgun by license holders is allowed on Texas public university campuses subject to the restrictions imposed by statutes and by the University President. Concealed carry is prohibited in some buildings on Texas State University Campuses. Please see <u>txstate.edu/campuscarry</u>. Open carry is **NOT** permitted on a university campus: "No person shall openly carry firearms or illegal weapons (as defined in Texas Penal Code 46.05a) or display a deadly weapon in a manner calculated to cause alarm (as prohibited by <u>Texas Penal Code Section 42.01</u>) while on university property. Exceptions to this prohibition include persons commissioned as peace officers in the state of Texas and federal law enforcement personnel." The university recommends calling the University Police Department by dialing "911" if you see someone carrying a gun on campus. They will respond and make contact with the individual to determine if that person has a License to Carry (LTC) and is appropriately carrying the weapon in compliance with all applicable laws and University policies. **All license holders are required to carry their license/permit on their person if they are also carrying their weapon.**

It is against university policy for faculty and instructors to forbid license holders from concealed carry. However, due to the sensitive nature of the topics discussed in this class, I am asking you to refrain from bringing a gun to class.
